



## Student Ensemble and Apprentice Agreement 2011-2012

*Please read each section and initialize below, indicating that you have read, agree to comply with, and understand each statement.*

### **Membership**

The Student Ensemble and its Apprentice groups I and II are the designated pre-professional training levels of The Georgia Ballet School, as well as the school's senior performing entities. Dancers of these levels must commit themselves to the program for the entire academic year: August 22, 2011 – May 26, 2012.

### **Training**

Each member is required to minimally attend a program of regular dance instruction. For students interested in making dance a career choice, extra ballet classes are very strongly encouraged. These classes are at no charge and are subsidized by the ballet on the dancer's behalf. Dancers may take classes on their free days, or they may add an extra class on a required day of study. Extra class schedules are designed on an individual basis according to the needs of each student and are generally taken at a lower level. Students must consult the artistic director, school director or assistant school director for a personalized schedule before taking extra classes.

The Georgia Ballet School's syllabus and curriculum are carefully and specifically designed to maximize each dancer's potential by means of a thorough grounding in our methods. Therefore, all Ensemble and Apprentice dancers (and all students of the Upper School) may not take dance classes of any kind outside of The Georgia Ballet School without approval and permission of the artistic director or school director.

The summer months are an extremely important time for student dancers, and provide an opportunity for dramatic improvement in skill growth. For this reason, The Georgia Ballet's summer intensive program, held in June for four weeks, will be a requirement of each dancer in the Ensemble/Apprentice program. For the benefit of our students, and in order to best guide them, attendance at summer dance programs other than The Georgia Ballet's intensive must be discussed with, and approved by, the artistic director or school director. To clarify, attendance at other programs does not waive the requirement for The Georgia Ballet's summer program.

## Weekly Rehearsal and Schedule Notes

Weekly rehearsal and schedule notes are posted each Monday on the website and the school bulletin board for the entire week. Sometimes, due to unforeseen problems or schedule conflicts, the schedule may be adjusted during the course of the week. This will be the exception rather than the rule; however, it is the responsibility of the **Ensemble/Apprentice Member** to check the schedule on a **daily** basis.

Those dancers listed for any given rehearsal are **required** to attend that rehearsal, which may include Saturdays or Sundays. Dancers must remain at all rehearsals – studio or theatre - until excused by the Artistic Staff.

## Absences

Absence from *class* and absence from *rehearsal* will be dealt with separately. For the purpose of monitoring class absences, the ballet school year will be divided into two semesters as follows:

1<sup>st</sup> Semester    August 22<sup>nd</sup> – January 14<sup>th</sup>

2<sup>nd</sup> Semester    January 16<sup>th</sup> – May 26<sup>th</sup>

### *Class Absences*

During a semester, a dancer must not be absent from any required class more than **four** times. The dancer's parent must call the School before class begins to report the absence. **A fifth absence from class within a semester will be considered unexcused and must be made up within one month.** A dancer with excessive absences may be dismissed from the program.

### *Rehearsal Absences*

All rehearsals are mandatory. Absence from rehearsal must be reported in advance and must be approved by the Artistic Staff prior to the rehearsal. In the case of illness, the dancer's parent must call the school before the rehearsal begins to report the absence. Any absence *may* result in a dancer being pulled from a performance. Excessive absence from rehearsal will result in a dancer being dismissed from the Ensemble/Apprentice program.

**Termination**

A dancer may be notified of dismissal from the Student Ensemble/Apprentice program for any of the following violations:

- A. Excessive absence
- B. Violations of the Student Rules of Conduct and/or Theatre Rules of Etiquette (to be found on website):
